

<u>Greetings from Our</u> <u>President</u>

Dear SBBA Members,

Welcome to the Fall edition of the SBBA Newsletter. The summer of 2023 goes on record as one of the rainiest in history. This summer was the secondwettest ever with over 20 inches of rain in a three-month period. Some scientists point to shifts in rainfall patterns as a result of world-wide climate change. Northeast storms that bring at least 1.5 inches of heavy rain in a day are expected to surge in coming decades.

Despite all of the rain, Salisbury experienced a fantastic summer! The beach center was alive with all of our favorite activities – the brandnew Carousel Pavilion opened for business in June, music on Friday and Saturday nights on the Broadway Mall, and fireworks on Saturday night. The Salisbury DPW did an exceptional job in keeping the beach center and surrounding area clean and free of trash and debris.

The SBBA had a very busy summer as well. We had our inperson Annual Meeting at the Blue Ocean Music Hall and honored our three past Presidents – Ron Guilmette, Al Peterson and Ray Champagne with the SBBA Distinguished Service Award. We hosted multiple Beach Clean-up days in which volunteers picked up trash and debris in the beach center and Broadway Mall. Fresh flowers and landscaping adorned the two Welcome Signs on Beach Road and North End Boulevard as well as

the Triangle and Railroad Park in the South End. We also sponsored the flying of over 60 flags on North End Boulevard and the beach center.

The SBBA wishes to recognize the tremendous work by the Salisbury Beach Partnership for their project to build the Carousel Pavilion which houses the historic 1909 Louff-Mangels Carousel. This project is one of the primary anchors of revitalizing Salisbury Beach and returning it to a world-class tourist destination.

The Merrimack River Beach Alliance (MRBA) Salisbury Beach Subcommittee has worked diligently over the past several months on several critically important projects – some successful and some that are still not where we need to be. More information on these projects is contained within this edition. We are continuing our efforts to protect and preserve our barrier beach and great salt marsh.

Town Manager Neil Harrington Report

Updates from Town Manager Neil Harrington for the SBBA's fall newsletter:

Street paving: In 2023, the Town paved and upgraded over 3.5 miles of roadway, including three major streets at Salisbury Beach – Central Avenue, Cable Avenue, and a large portion of Railroad Avenue. There are sewer upgrades that need to be completed on the southern end of Railroad Avenue before this section of the roadway can be re-paved. It is anticipated that the sewer upgrades will take place in the spring of 2024.

North End Boulevard reconstruction project: On Sept. 27, the Mass. Dept. of Transportation (MassDOT) held its fifth public meeting on a proposed project to reconstruct and make several safety improvements to North End Blvd. from Beach Road to the New Hampshire border. As presented, the preferred alternative plan for the project would include the following - a complete repaving of the roadway, a narrowing of the travel lanes to 10.5 feet in both directions, bump-outs at intersections with side streets and at all crosswalks, pedestrianactivated signals at all crosswalks, improvements to current drainage problems along the roadway, a shareduse bike and pedestrian path on the western side of the roadway, a buffer zone between the southbound travel lane and the curb, and maintenance of the current eastern edge of the roadway. Although much of

the paved roadway on the eastern side of the street is within the State right-of-way, residents will be allowed to continue to park in this area as long as the parking does not intrude into the northbound travel lane.

Following the meeting, MassDOT announced that, based on the current level of Town and community support, the preferred alternative plan for the project would be moved forward to the 25% design phase and a public hearing will be scheduled at some point in the near future. This is important because once the 25% design public hearing is held, the project will be eligible to compete with other projects in our region for funding, after which it will be placed on the list for future construction.

Beach improvements: At the beginning of the 2023 beach season, the Town invested \$80,000 in federal grant funding to purchase new barrels, benches and beach furniture for the Beach Center. This is a continuation of the improvements that the Town has made in the Center over the past few years. The Town is also in the process of planning for a larger re-design of the Beach Center area, and we have secured a \$130,000 grant from the State to begin to design alternatives that will include more recreational opportunities for residents and visitors, a safer pedestrian experience, and greater beautification of the entire area.

Beach resiliency: Through its involvement in the regional

Merrimack River/Beach Alliance (MRBA), the Town is working diligently with our legislators and the State's Dept. of Conservation and Recreation (DCR) to address short- and long-term dune resiliency issues at Salisbury Beach. One of the most important components of this effort will be the development of a new Beach Management Plan by DCR. The previous plan lapsed several years ago and there is currently no guidance or plan in place to address beach renourishment after major storms and yearly upgrades to the dune system to support long-term resiliency. DCR has pledged that the Town will be consulted and will have input before any new management plan is finalized.

Merrimack River Beach Alliance (MRBA) Salisbury Beach Subcommittee

The MRBA Salisbury Beach Subcommittee has been meeting throughout this year to discuss access way damage and dune erosion caused by Winter Storm Elliott on December 22, 2022. In May of this year, our efforts produced positive and tangible results. New DCR Commissioner Brian Arrigo became personally involved. Senator Bruce Tarr contacted Governor Healy and walked the beach to see the damage first hand. The SBBA contacted local TV news channels for coverage of the issue. As a result, structural engineers from DCR and the Town of Salisbury assessed damage on walkways and stairs at Access 8, 9 and 10 and determined that they could be repaired and reopened in time for the summer season. This was accomplished by the end of June.

At the same time, the subcommittee wanted to ensure that we did not lose sight of two other critically important initiatives – the 1.5-mile dune restoration project between Access 5 and 10 and the Salisbury Beach Management Plan. The following are the steps that were taken in that regard:

Environmental Consultant Tom Hughes developed an erosion and remediation plan for Access 5 - 10. An onground survey of this entire area is in process to refine estimates for the amount of sand required and analyze the

private/public property line for this area.

A senior representative from DCR, Patrice Kish, has been added to our subcommittee meetings and has attended the August, September and October meetings. Patrice is the Chief of Planning and Engineering and is a direct report to Commissioner Arrigo. The rewrite of the Salisbury Beach Management Plan is 75% complete and is scheduled for an internal DCR review in November. DCR has assured the subcommittee that we will be able to review and comment on the draft plan prior to its completion.

Despite these positive steps, there are two major issues that are preventing progress on the dune restoration project. The first is our inability to utilize the Salisbury Beach Preservation Trust Fund to help pay for the project. This is currently at an impasse due to DCR's legal position that none of these funds can be utilized to place sand on private property. Senator Tarr continues to have discussions with senior Administration officials regarding this point. Also at an impasse is pending legislation to make the Trust Fund language more specific relative to what it can be used for and to clarify the public/private land issue. This bill is still in Legislative Committee and needs the buy-in of DCR to move forward.

As a result, the Town of Salisbury is considering a short-term plan to provide property owners with an option to buy and place a limited amount of sand on their

properties before the winter storm season arrives. This would be a similar to what five owners did near Access 7 prior to Hurricane Lee in September. The process involves creating an overarching Notice of Intent (NOI) which needs approval from the Conservation Commission as well as DCR and other state permitting requirements. At the time of this article, this concept is still in the discussion stages.

The subcommittee will continue to fight and advocate for the citizens of Salisbury Beach on these projects. Although frustrating at times, we feel that our subcommittee provides the most viable option to continue to pursue our common goals for short-term dune restoration and long-term strategic management and protection of our barrier beach. We will not give up!!

Fall Town Meeting

The Fall Meeting was held on Monday, October 23, 2023 at the Salisbury Elementary School. Twenty-five articles were presented and all passed. Article 25 was the most controversial. The article sought to amend the town's zoning map, changing a portion of Old County Road where the project, the construction of 19 housing units on a .69 acre triangular lot at Foote's Ice Cream stand, to a Residential 2 zone. The article passed but is pending approval by the state Attorney General. Voters also approved \$57,000 for a new Salisbury police patrol supervisor vehicle.


