The SBBA also wishes to recognize the tremendous work by the Salisbury Beach Partnership for their efforts to revitalize Salisbury Beach and, in particular, for their project to build the Carousel Pavilion which will house the historic 1909 Looff-Mangels Carousel. We look forward to its completion and opening in early 2023.

The Salisbury Beach Resiliency Task Force is now part of the Merrimack River Beach Alliance (MRBA) and has been formally recognized as a subcommittee of that organization. We are continuing our efforts to protect and preserve our barrier beach and great salt marsh.

### HISTORIC CAROUSEL PAVILION UPDATE – CLOSER TO OPENING

The non-profit Salisbury Beach Partnership is well on its way towards completion of the new pavilion which will house the historical 1909 Looff-Mangels Carousel. Much has been accomplished since I last reported progress in our Spring Newsletter. I was recently privileged to receive a tour of the new pavilion conducted by Partnership president, Mr. Wayne Capolupo. This article reflects the essence of what I learned during that tour.

The "roundhouse", the room which will actually house the carousel, is complete except for windows which have been delayed due to supply chain issues. The windows for the rest of the building have been delivered and installed.

The roof is complete including the "witch's hat" on the top of the building. Interior framing which defines areas such as the caterer's kitchen, bathrooms, 50- person function room, utility room and micro-branch of the Newburyport Bank is complete. Yes, Salisbury Beach will finally have on-site banking services available to residents and visitors. The micro bank will be staffed during the tourist season and will provide remote, on-line banking services off-season.

Rough-in plumbing, electrical and HVAC services are complete. Since this will be a year-round operation, the building will have radiant in-floor heating to provide a comfortable environment in any weather. The radiant heating in the roundhouse is complete and installation in the rest of the building is now underway. This building is intended to be a landmark focal point for Salisbury Beach for many generations to come and to insure that, the 99 pilings that support the building have been tripleimpregnated with wood preservative to guarantee a long life of service to residents and visitors.

The pavilion and carousel are expected to be open to the public in late January or mid-February 2023 at which time the historic 1909 carousel will finally have a new permanent home. See you at the Salisbury Beach Carousel Pavilion.

Financial support from the public is critical to the success of this non-profit endeavor which is already beginning to remake the face of the beach center. # Salisbury Beach Resiliency Task Force

The Resiliency Task Force is now part of the Merrimack River Beach Alliance (MRBA) and has been incorporated into that organization as the MRBA Salisbury Beach Subcommittee. The new subcommittee has had two meetings this summer and fall to discuss beach resiliency and erosion mitigation issues. The follow is a summary of our meetings, which were chaired by Senator Bruce Tarr.

Senator Tarr discussed a recent conversation with new DCR Commissioner Doug Rice in which they covered several important topics, as follows: Communication – Sen Tarr emphasized that communication between DCR and Salisbury is of utmost importance. Salisbury needs DCR's participation and involvement in everything that we are attempting to do on the beach.

Beach Management Plan – Sen Tarr conveyed the sense of urgency in getting a revised plan in place as soon as possible. They also discussed the concept of filing a Notice of Intent (NOI) to reinstate the expired plan on an interim basis.

Immediate placement of sand – they discussed the urgent need for sand on distressed areas of Salisbury Beach (between Access 5 & 7). Important first steps are to resolve issues of permitting and funding. Commissioner Rice was invited to walk Salisbury beach with the subcommittee.

Several other topics were discussed, as follows:

# Short term dune restoration

**project** – we emphasized the need for a dune restoration project between Access 5 & 7 to address this vulnerable area. We also discussed sources of funding for this project as well as the need for a long-term strategic plan to address erosion issues.

# Preservation Trust Fund -

we stressed the need for an update of DCR's 2022 revenues and expenditures in the Trust Fund. We also highlighted the need to refile legislation that was proposed but tabled last year in which we clarified how Trust Fund monies are spent and addressed the public/private land issue. Sen Tarr stated that he will be refiling this bill in the first two weeks of next year.

### DCR Upper Northshore Regional Sediment Study –

the subcommittee reviewed this January 2021 study commissioned by DCR. The key findings of the study were as follows: Substantial sand nourishment to the shoreline with periodic replenishment is an effective management solution for Salisbury: Nourishments are designed for a lifespan. For example, the study modeled a scenario in which a properly replenished dune should have 30% of fill remaining after 15 years The study recommended the creation of a Sand Stockpile Area (SSA) for emergency use.

The subcommittee fully supports this study and felt that it could be the foundation for a longterm plan for Salisbury Beach.

# North End Blvd Update

There is good news to report on the status of the North End Blvd reconstruction project. The Massachusetts Department of Transportation has advised Neil Harrington, Salisbury Town Manager, that they are working on a revised design that will accommodate many of the suggestions and concerns raised by SBBA members and town residents. Thank you very much for taking the time to share your comments and opinions via SBBA's survey. The results of the survey showed that our membership is very excited to see the proposed roadway improvements, including new crosswalks, improved drainage, and repaying, come to fruition. However, your comments and input on the survey were also invaluable in illustrating the potential hardships that property owners could face. The Salisbury Selectmen and Town Manager attended the SBBA's annual meeting and listened to our members' top concerns about loss of parking and driveway safety. We also appreciate the efforts of the Salisbury Beach Citizens for Change in bringing forth a petition on this matter which many SBBA members signed.

After the SBBA annual meeting, the newly established SBBA North End Blvd Subcommittee reached out to Town Manager Neil Harrington to follow up on member concerns. Mr. Harrington confirmed that the DOT is working on a revised plan that focuses on safety as its highest priority, as well as minimizes any loss of parking. Specifically, according to Harrington, the new plan preserves the eastern shoulder of North End Blvd as it is today. It also replaces the originally proposed separate bike lane on the western side of North End Blvd with a shared use path. Neil believes that this plan will result in saving as much space as possible for parking on the eastern side of the road.

There is a virtual Mass DOT presentation tentatively scheduled for the week of

November 28th. We are optimistic that this will be a great project that will enhance our community. The SBBA will post exact details for attending the session on our web page at https://www.sbba.us/dot. An email will be sent to the membership when the details are finalized.

The SBBA is also continuing to pursue a reduction in the speed limit on North End Blvd. Neil Harrington has agreed to work with us on this effort. We greatly appreciate Neil's consideration of the SBBA membership's safety concerns and will update you on this soon.

# **Fall Town Meeting**

At the Annual Fall Town Meeting held on October 24, residents approved spending \$700,000 to pave various streets in town, \$146,994 from Comcast's payments to the Town from franchise fee and equipment funding to support SCTV cable service, \$57,000 for the funding of a new patrolman and \$80,025 for the funding of the first year of negotiated contracts with town employees.

Town meeting members also approved \$36,500 for repairs to the stone wall at the Colonial Burial Ground, \$150,000 to purchase and equip a new trash truck with rear packer, \$20,000 to hire a part-time employee to assist the town in remaining compliant with the Community Rating System with the National Flood Insurance Program, and \$50,000 to replace 180 water meters on Ring's Island.

Residents also approved two warrant articles presented by resident Lynn Welch amending bylaws to have the Board of Selectmen rather than the Town Manager appoint members and associate members to the Zoning Board of Appeals and members to the Conservation Commission. Once the state Attorney General reviews the vote on the Zoning Board of Appeals it will go into effect. Voters must also approve the change in the appointing authority at the polls for the Conservation Commission at the next town election in May for the changes to be implemented as that vote will be a change in the town's charter.

A warrant article presented by resident Mark Warcewicz to promote the creation of new small ground-mounted solar panels was not allowed to move forward as the Planning Board had not yet made a recommendation on the article.

The Master Plan Committee recently completed its drafted version the Master Plan with the assistance of The Barrett Planning Group, LLC. Salisbury last updated its Master Plan in 2008. The Master Plan articulates a vision for the future and sets a basis for future decision-making. The following sections were included in the updated document: Land use; Transportation and Circulation; Economic Development; Climate Change and Sea Level Rise Resiliency; and Community Health. On October 12th the Planning Board reviewed and adopted the updated Master Plan.
